If a complaint cannot be resolved, we will refer you to The Motor Ombudsman – a CTSI certified Alternative Dispute Resolution (ADR) provider. The Motor Ombudsman may be able to help you resolve the matter without the need for litigation. The majority of the Mitsubishi dealer network subscribe to The Motor Ombudsman service, however some use an alternative certified organisation.
